On Monday, Nifty September future ended with a gain of 0.84% and whereas Nifty Bank September future ended with a gain of 0.96%.


- Nifty September future ended with a premium of 44.20 points compared to its previous day's premium of 23.25 points. Nifty Bank September future ended with premium of 115.10 points compared to its previous day's premium of 121.25 points.
- Nifty Future-OI has rose by 1.29% and currently stands at 14.18 million shares whereas Nifty Bank Future-OI rose by 10.52%.
- India VIX rose by 0.56% and ended at 19.66 compared to previous day's close of 19.55. Nifty PCR-OI has increased from 1.04 to 1.21.
- During the day build up of fresh long is seen EXIDEIND, DIXON, POWERGRID and IDFCFIRSTB and short covering is seen in HINDALCO, M&MFIN, INTELLECT and ALKEM.
- During the day build up of fresh short is seen in BAJAJ-AUTO, SYNGENE, CUB and ASTRAL whereas unwinding of existing long is seen in INDIAMART, HONAUT, DABUR and MFSL.


