STOCK IN FOCUS

- ▶ **Apollo Tyres** (ATL) surged ~4% in yesterday's trade on the expectation of better performance in coming quarters due to sharp drop in international rubber prices led by concerns over rising inventories and soft demand from China.
- ► ATL currently enjoys ~28% market share in the TBR segment. As radialisation forms only 45% of domestic TB tyre market, we see a significant scope for radialisation in the domestic CV segment, which would benefit manufacturers like ATL, going forward.
- Unlike 1HFY18, we envisage ATL's performance to improve, going forward owing to steady stabilisation in Hungarian operations and shifting to OEM segment.
- ► At CMP, the stock trades at 21.1x and 11.1x FY18E and FY19E earnings, respectively which appear to be attractive, in our view.
- ► We reiterate our fundamental BUY rating on the stock with Target Price of Rs305.



MARKET SYNOPSIS

- Yesterday, NSE-NIFTY remained sideways post crossing its intraday resistance of 10,345 level in absence of major headlines in the market, where sharp decline in the late noon trades trimmed the daily gains.
- ► Finally, NIFTY closed the day with rise of 28 points at 10,327 mark.
- NSE Cash segment reported turnover of Rs33,644 crore as compared to Rs27,900 crore earlier.
- Overall market breadth remained positive, where 965 stocks advanced against 766 declined stocks.



Mixed trend was observed across all the sectoral indices during the day, where Pharma emerged as a top gainer with the increase of 2.2%. However, on the other hand PSU Bank and Realty indices reported the highest decline (0.9% and 1.1% respectively).

NSE-NIFTY OUTLOOK

- ▶ Finally, NSE-NIFTY managed to settle above its make-or-break level 10,300 (23.6% Fibonacci Retracement level of prior up-move from 9,688 to 10,490 levels) and also, it rose to 9-day closing high. Though, NIFTY ended the session forming an indecisive pattern (i.e. Doji) on the daily chart, (i) positive market breadth (ii) increase in market participation and (iii) rise in the technical indicators are signaling strength in the index, which is support it revisit the life-time-high of 10,490 level. In case of decline, NIFTY will find support at 10,100 and then at 10,000 levels.
- As for the day, support is placed at around 10,265 and then at 10,230 levels, while resistance is observed at 10,385 and then at 10,430 levels.

Derivatives Snapshot

- ▶ Nifty opened higher on back of global cues but saw sharp profit booking in the last one hour of trade as Bank Nifty underperformed the broader markets. Nifty closed up by 28 points at 10,327 levels. Among the nifty stocks 29 stocks advanced and 20 declined during the day.
- ► Sectorally, Pharma, Media and Auto gained by 2.2%, 0.9% and 0.4% while minor profit booking was witnessed in Realty and FMCG to decline by 1.1% and 0.6% respectively
- ▶ Broader market indices remained flat with NIFTY 100,200 and 500 to close up by 0.3% average while midcap indices and small cap indices gained by 0.1% and 0.2% respectively.
- Nifty November futures ends with 25 points premium at 10,352 mark, while on other hand, Bank Nifty November futures ended with the premium of 62 points at 25,819 mark.
- ▶ Nifty has seen good recovery from the lows of 10,100, on the higher side crossover of 10,400 levels will attempt to cross all time high. Nifty 10,300 PE has seen addition of 7 lakhs shares taking OI to 54 lakhs shares while on the higher side 10,500 have 61 lakhs shares capping the upside.

Sectoral Activity: Amongst sectoral index, Pharma and Media remained in focus with positive momentum.

Stock Activity: Sun Pharma and ZEE observed build up in long position.
