

### **MARKET PREVIEW**

**US:** U.S. stocks were mixed after the close on Friday, as gains in the Basic Materials, Utilities and Telecoms sectors led shares higher while losses in the Consumer Services, Technology and Financials sectors led shares lower. At the close in NYSE, the Dow Jones Industrial Average gained 0.05% to hit a new all time high, while the S&P 500 index declined 0.09%, and the NASDAQ Composite index lost 0.09%.

**Asia:** Markets in Asia opened near flat on Monday, seeking direction ahead of a relatively data-light week in the region, while investors had a muted reaction to the risks surrounding a failed military coup in Turkey. Japan Market is closed Today/

India: India stocks were lower after the close on Friday, as losses in the IT, Technology and Power sectors led shares lower. At the close in NSE, the Nifty 50 fell 0.28%, while the BSE Sensex 30 index lost 0.38%. Market is expected to open on a flattish note and likely to witness range bound session during the day.

**Economy:** U.S. industrial production rose in June on large gains in automotive manufacturing and utility output. consumer prices increased for a fourth straight month in June as Americans paid more for housing, gasoline and healthcare, pointing to steadily rising inflation pressures.

China's residential land prices rose faster in the second quarter than in the previous three months, while those for industrial land posted slower growth. The Industrial Production rose to 6.2%, from 6.0% in the preceding month. Chinese GDP remained unchanged at an annual rate of 6.7%, from 6.7% in the preceding month.

Consumer price inflation in the euro zone remained unchanged last month at a seasonally adjusted annual rate of 0.1%.

**Commodities:** Oil prices were little changed in early Asian trade on Monday as traders shrugged off the impact of Friday's attempted coup in Turkey. A stronger dollar weighed on prices, although upbeat economic data from the United States and China that supported the outlook for global oil demand lent support.

Gold eased off gains in Asia on Monday in cautious trade after a failed weekend military takeover in NATO ally Turkey was assessed with sentiment that political risk for now from the event was on the wane.

**Currency:** The U.S. dollar gained on the yen as investors unwound safe-haven trades in the wake of the failed coup in Turkey, while a giant takeover bid in the tech sector and the promise of central bank stimulus lent support to equities.

### NGT orders criminal action against Telangana officials

The National Green Tribunal (NGT) has ordered criminal proceedings against officials of the Telangana State Power Generation Corporation for undertaking construction of a 1,280-Mw thermal power plant project without mandatory environmental clearance. (BS)

### PMO asks Kant to chalk out detailed plan for one sick PSU

NITI Aayog Chief Kant has been asked by the PMO to identify one sick PSU, along with a detailed plan for its sell-off or eventual liquidation, before moving on to other such cases. This follows a road map prepared by NITI Aayog and submitted to the PMO last month on strategic sale or closure of some sick public sector units. (BS)

### Merchandise exports up after 18 months in June

Merchandise exports rose in June after 18 months of decline, the longest fall in recent times. Exports rose 1.3% to \$22.57 bn, against \$22.28 bn in the same month a year before, govt data showed. As many as 24 items, including engineering, electronic goods, drugs & pharmaceuticals and carpets & handicrafts, of 30 major ones tracked by the commerce minsitry showed growth; 13 had done so in May. (BS)

### India negotiates on mandatory change of refrigeration technology

India will be negotiating at the Montreal Protocol with one hand tied behind its back when the talks begin on Monday at Vienna. Countries gathering at Vienna are to decide how and when to phase down the use of refrigerant gases that are less damaging for the ozone holes than the ones used previously but add to global warming. (BS)

### SC refuses to stall CERC proceedings on compensatory tariff

SC refused to stall the proceedings in the Central Electricity Regulatory Commission's (CERC) in compensatory tariff case but said that the order will be subject to its scrutiny. (BS)

### **Congress indicates softening on GST**

There's a perceptible change in the Congress party's position, hitherto opposed, on the proposed national GST Bill. On Sunday, Ghulam Nabi Azad, its leader in the Rajya Sabha, said the party was ready to support any legislation in the interests of "the people, business and India". "We are not for preventing any Bill from being passed," he said after an all-party meeting on the issue. (BS)

### **Google CEO Sundar Pichai defends Europe tax practices**

Google CEO Sundar Pichai hit back at accusations that the global internet giant failed to pay enough taxes in Europe, and warned of the potential fallout from Britain leaving the EU. (ET)

### General Motors escapes some claims from 2014 recalls

A US judge dismissed some claims brought against General Motors by customers seeking compensation for a drop in vehicle resale values after a rash of safety recalls in 2014, including one for a faulty ignition switch. (BS)

### Alstom seals 800-mn-euro train deal with Dutch rail

The Dutch national rail authority concluded an 800-million-euro deal on Saturday with French transport giant Alstom to buy 79 new high-speed trains, set to go into service by 2021. (BS)

### **GM Earnings This Week to Shed Light on Big Investments**

Nearly a decade ago, General Motors Co. engineers and Carnegie Mellon University researchers shuttled between Detroit and Pittsburgh working on a moonshot project: developing cars that could drive themselves. The research put GM in the driver's seat on the nascent technology, but the executive churn that resulted from its financial struggles led to a reordering of priorities. (WSJ)

Hawaii Rejects NextEra's \$4.3 Billion Bid for Hawaiian Electric Hawaiian officials rejected NextEra Energy Inc.'s \$4.3 billion bid to buy the state's biggest corporation, Hawaiian Electric Co., unconvinced it would have benefited utility consumers or helped the state achieve its aggressive goal to become more energy self-sufficient.
