

Highlights

- ❖ The Nifty was down by 32.15 points or 0.32% to settle at 9,984.80.
- ❖ As per the OI data, the maximum OI outstanding for Calls was at 10000 SP and that for Puts was at 9800 SP. Besides, for trading purpose, one could Buy NIFTY with the SL of 9940 for the Target of 10100.
- ❖ Nifty October 2017 futures closed at 9992.50 on Wednesday at a premium of 7.70 points over spot closing of 9984.80.
- Among Nifty calls, 10100 SP from the October month expiry was the most active call with an addition of 7.4 lakh open interests. Among Nifty puts, 10000 SP from the October month expiry was the most active put with an addition of 8.1 lakh open interests.
- Nifty October futures saw an addition of 10.4 lakh units, taking the total outstanding open interest to 2.57 Cr. units.
- ❖ Among most active underlying, Tata Steel witnessed a contraction of 20 thousand units of Open Interest in the October month futures contract, followed by Reliance Industries witnessing a contraction of 3.2 lakh units of Open Interest in the October month contract, State Bank of India witnessed an addition of 22 lakh units of Open Interest in the October month contract.
- The top gainers on Nifty were Bharti Airtel up by 5.56%, HPCL up by 3.92%, Bharti Infratel up by 2.78%, Indian Oil Corporation up by 1.90% and TCS up by 1.68%.
- On the flip side, Yes Bank down by 2.74%, Vedanta down by 2.35%, SBI down by 2.12%, Tata Motors down by 1.98% and Indiabulls Housing down by 1.79% were the top losers.


