

Market Round Up

Nifty opened above 9200 levels in Monday's session and thereafter continued to inch upwards on back of fresh buying in some of the heavy weight stocks that led nifty to all time high levels and finally to closed around 9238 levels up by 64 points.

- From lower levels short covering was seen in nifty fut. and it shed almost 5.80 lakh shares whereas bank nifty fut. added fresh long positions.
- Fresh buying interest was seen in metal, capital goods, nbfc and pharma sector. Major long accumulation was seen in stocks like wockpharma, godrejind, cesc, justdial, jisljaleqs and lt.
- Short unwinding was seen in oil&gas, cement and power sector. Stocks like reliance, gail, torntpharm, bharatforge, hdfc and acc.
- Mfsl, ujjivan, dishtv, mcdowells, torntpharm and techm were some of the stocks that added short positions.

Taking ahead Mondays rally, today markets are expected to open on positive note and will continue to see buying interest at lower levels. Nifty has given a breakout from its resistance zone of 9200 and any intraday dip towards 9200-9180 levels can be used to initiate fresh long positions with short term targets of 9320-9380 levels. On lower end heavy put writing has been seen around 9000 levels and that will act as strong support zone for indices in short to medium term.

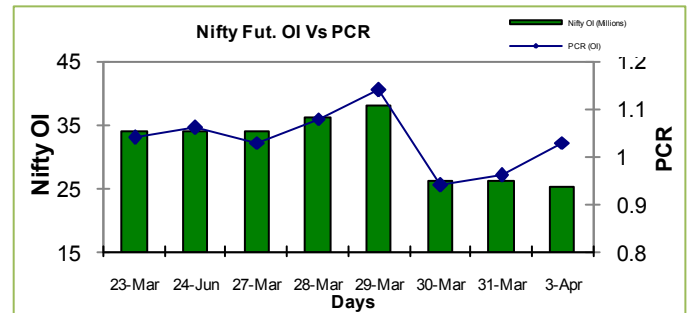
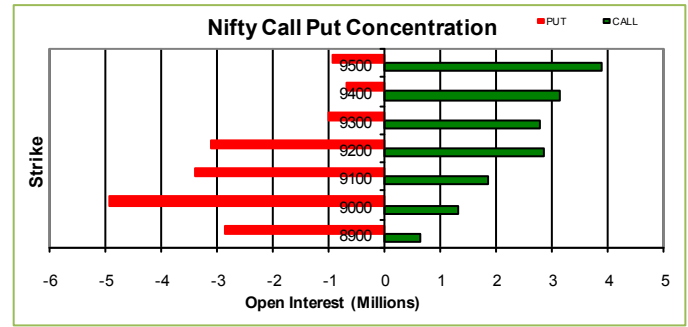
