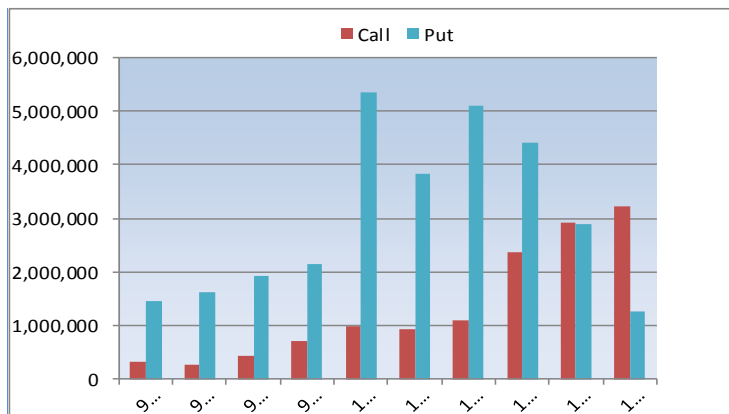


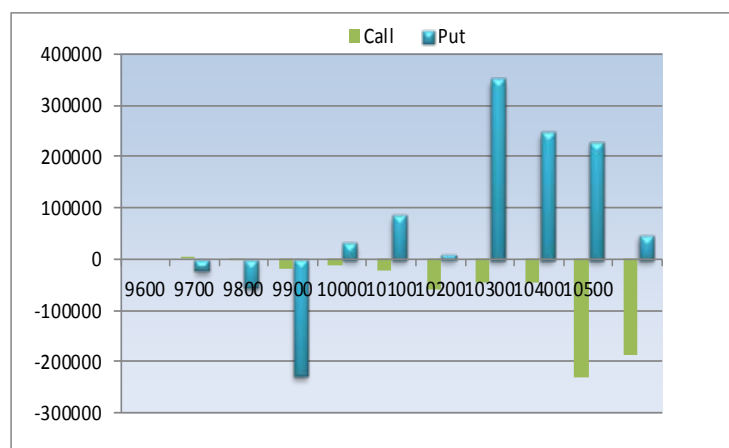
## Highlights

- ❖ The Nifty was down by 16.70 points or 0.16% to settle at 10,423.80.
- ❖ As per the OI data, the maximum OI outstanding for Calls was at 10500 SP and that for Puts was at 10000 SP. Besides, for trading purpose, **one could Buy NIFTY with the SL of 10380 for the Target of 10500-10550.**
- ❖ Nifty November 2017 futures closed at 10455.00 on Thursday at a premium of 31.20 points over spot closing of 10423.80.
- ❖ Among Nifty calls, 10500 SP from the November month expiry was the most active call with a contraction of 1.8 lakh open interests. Among Nifty puts, 10400 SP from the November month expiry was the most active put with an addition of 2.2 lakh open interests.
- ❖ Nifty November futures saw an addition of 10.6 lakh units, taking the total outstanding open interest to 25.38 mn units.
- ❖ Among most active underlying, ICICI Bank witnessed an addition of 39.9 lakh units of Open Interest in the November month futures contract, followed by Divi's Laboratories witnessing a contraction of 20 thousand units of Open Interest in the November month contract, State Bank of India witnessed an addition of 14.6 lakh units of Open Interest in the November month contract.
- ❖ The top gainers on Nifty were Aurobindo Pharma up by 3.77%, Lupin up by 3.37%, Sun Pharma up by 2.75%, Power Grid up by 2.69% and Dr. Reddy's Lab up by 2.28%.
- ❖ On the flip side, Tech Mahindra down by 4.36%, Hero MotoCorp down by 2.76%, Bharti Infratel down by 2.03%, SBI down by 1.74% and ONGC down by 1.60% were the top losers.

## Nifty Options – Change in OI

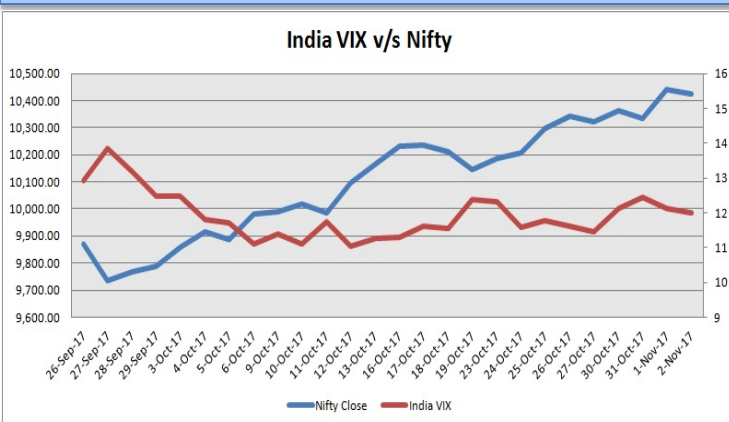

- ❖ The India Volatility Index decreased by 1.09% and reached 12.00.
- ❖ The Nifty Put Call Ratio (PCR) finally stood at 1.38 for November month contract.
- ❖ The top five scrips with highest PCR on OI were Repco Home Finance (7.10), Godrej Consumer Products (3.90), JSW Energy (1.62), Cholamandalam Investment and Finance Company (1.49) and Apollo Hospitals Enterprise (1.40).
