Foreign investors have pumped in nearly USD 2 billion in the country's capital market in the last seven trading sessions due to finalization of GST rates for the bulk of the items and forecast of a normal monsoon.

The Trump administration and top Republicans in US Congress are within a few weeks of agreeing on central aspects of a tax overhaul plan that will determine the contours of legislation now expected in September. Under pressure from business groups and rank-and-file Republicans, Trump officials and Congressional leaders still need to decide how much to slash tax rates and if the package should increase the federal budget deficit, administration said.

British Prime Minister Theresa May secured a deal on Saturday to prop up her minority government but looked increasingly isolated after a botched election gamble plunged Britain into crisis days before the start of talks on leaving the European Union.
