



MARKET PREVIEW

US: U.S. stocks rose considerably on Friday, as stronger than expected jobs data in July helped bolster the financial sector, propelling the NASDAQ Composite index and the S&P 500 to all-time record closing highs.

Asia: Asian shares rose on Monday and the dollar stood tall after a stronger-than-expected July jobs report lifted confidence in the strength of the US economy - heightening expectations that the US Federal Reserve could hike interest rates this year.

India: Benchmark share indices ended 1% higher tracking a rally in European shares after the Bank of England on Thursday lowered its key interest rate by 25 basis points and unveiled a stimulus package to cushion the impact of its exit from the European Union. The S&P BSE Sensex ended up 364 points at 28,078 and the Nifty settled 132 points higher at 8,683. In the broader markets, BSE Midcap and Smallcap indices ended up over 1.5% each. Market breadth remained strong with 1817 gainers and 917 losers on the BSE. Market is expected to open with gap up and likely to witness up move during the day Economy: The U.S. economy created more jobs than expected in July. U.S. nonfarm payrolls rose 255,000 in July. Economists had expected jobs growth of 180,000. June's figure was revised to 292,000 from a previously reported 287,000. Average hourly earnings up 0.3% vs. forecast rise of 0.2%.

The U.S. trade deficit rose to a 10-month high in June as rising domestic demand and higher oil prices boosted the import bill while the lagging effects of a strong dollar continued to hamper export growth. The trade gap increased 8.7% to \$44.5 billion in June, the biggest deficit since August 2015. May's trade deficit was revised slightly down to \$41.0 billion.

Bank of England Deputy Governor Ben Broadbent said on Friday he would support cutting interest rates again this year, but ruled out using a new bank funding scheme to bring in negative rates by the back door.

Commodities: Crude oil prices edged higher in Asia on Monday with trade data from China, the world's second largest importer, expected to set the regional tone.

Gold prices drifted lower on Monday in Asia as investors awaited trade data from China for direction.

Currency: Speculators pared back bullish U.S. dollar bets this week, as investors were dismayed by poor U.S. economic growth data for the second quarter that dampened expectations for an interest rate hike this year.

India's pulse import worth over Rs 25,500 cr in FY16

India's pulse imports rose by 50% in value terms to Rs 25,691 cr in 2015-16, with in-bound shipments totaling 5.8 mn tonnes. The country imported 4.58 MT of the staple worth Rs 17,063 crore. (ET)

RBI gives nod for three assest reconstruction companies

RBI has given its nod to three new asset reconstruction cos, to be set up by US-based Encore Capital, Ahmedabad-based CFM, and Vishakhapatnamheadquartered Maximus ARC. The central bank handed out approvals to only three out of 14 applicants, leaving others, including those of private equity firm JC Flowers and businessman Sudhir Walia, hanging fire. (ET)

Govt mulls pruning tax exemption list

When the GST is enforced, exemptions from central excise on tea, coffee, food might go about 200 items, including premium tea and coffee, ready-to-eat food and branded biscuits, could lose tax exemptions when the goods and services tax comes into effect. (BS)

NHAI eyes Rs 50k cr from bond sale, EPFO, LIC get on board

The bond sale to EPFO is part of the fund-raising plan of NHAI for highway projects. EPFO has invested in NHAI bonds under the PSU category. LIC too in-principle has agreed to invest in the bonds and will take up the issue at its board meeting. (FE)

FPIs stay bullish on India, pump in Rs 2,300 cr in a week

It comes following a four-month high inflow of Rs 12,612 crore in the preceding month. This was the highest net inflow since March, when FPIs had pumped in Rs 21,143 crore in the stock markets. The move was attributed to the rate cut by Bank of England and passage of GST Bill in the Rajya Sabha. (FE)

Jet.com deal with Wal-Mart hinges on keeping founder

The latest push to speed delivery of its products comes as the company ships an increasing number of packages worldwide. Amazon's parcel volume was an estimated 1 billion packages in 2015. (ET)

Nissan in talks to sell battery biz to Panasonic

Nissan Motor is in talks with Panasonic and overseas companies including Chinese firms over the possible sale of its controlling stake in a car battery manufacturing venture. The Japanese automaker wants to sell its 51% stake in Automotive Energy Supply Corporation, which makes lithium-ion batteries for electric vehicles. (ET)
