World Bank Ranked India 100 In Ease Of Doing Business Among 190 Nations

World Bank has ranked India 100 for 2018 from 130 in 2017, a huge leap of 30 places in ease of doing business compared to other 190 Nations (Brazil-125, Russia-35, China-78, South Africa-82). Moreover, Investor Protection given a rank of 13 in 2017 and 4 in 2018, Getting Credit-44 in 2017, 29 in 2018, Paying Taxes-172 in 2017 and 119 in 2018, Resolving Insolvency-136 in 2017 and 103 in 2018.

Construction Permits in India given a rank of 185 in 2017 and 181 for 2018, starting a business-155 in 2017 and 156 in 2018, Registering Property-138 in 2017 and 154 in 2018.

Fed is expected to keep its rate unchanged today at 11:30PM IST, 3 Month treasury which is a clear indicator to predict interest rate decision suggest that Fed Chairperson Jannet Yellen will keep its rate unchanged today.

Nifty closed at 10335 after making a high of 10368, the cash benchmark Smallcap Index closed at 8550 after making new record high of 8563. Chemical, Automobile and Realty were top three performing sectors yesterday. In chemicals, India Glycol rose 14.90%, Kiri Industries was up by 13.29% and Gujalkali zoomed by 8.65%.
