

# FII & Pro Created Short Position For 1.5 Lakh Contracts, Previous Day Low Become Crucial For Market Wednesday, November 08, 2017

Yesterday FII & Pro has created short position for 149442 contracts; average sell position per day is for 43000 contracts. Thus they have created 3.5 times sell position of their one day average position. If Nifty and Smallcap Index breaks its previous day low of 10341 and 8522 respectively, then we might see further downside in market.

Dynamic Smallcap Index is also an important indicator for market direction which yesterday closed at 1745; recent high of the Index is at 1772. If Dynamic Smallcap Index goes below 1745, we might see selling coming in the market.

Nifty Index yesterday fell by 0.97% and closed at 10350 after making low of 10341, the Index made high of 10486. Smallcap Index decline by 1.73% and closed at 8559 after making low of 8552, the Index made high of 8782.

Nifty Future is opening gap- up by 4 points against yesterday close of 10410 as indicated by SGX Nifty which is currently trading at 10414.
