### **Pharma Sector Showing Buying Strength**

Yesterday Pharma stocks zoomed by 2.05%, the sector is performing from last 2 weeks. Hester bio rose 14.79%, Suven was up by 3.81%, SMS Pharma was buy circuit with 20% jump and Gufic Bioscience rose 7.77%.

Among stocks Himadri Specialty Chemical (HSCL) rose 8.16%, the stock has jumped 93% after 11th Aug low. The Company Caters to 65% of the Indian aluminium and the graphite electrode industry requirement of coal tar pitch. From last 1 month graphite manufacturing companies are doing very well after government raised its focus on electric vehicles.

Market witnessed profit booking in 1st half, thus most of the stocks declined on profit booking. However as market showed some recovery few stocks jumped from their respective lows. Dwarikesh moved up by 8.89%, Tata Metalik rose by 5.70%, Graphite Jumped by 5.50% and Vindhya Tele rose by 5.43% from their day's lows. Today Nifty opening gap down by 45 points at 10092 from yesterday close of 10137 as per SGX Nifty.

### NIFTY OUTLOOK & OPEN INTEREST IN INDEX OPTION

The Benchmark Index Nifty yesterday closed at 10122 after making a low of 10058.

In last 10 days, FII and PRO in combined have bought 51632 contracts in Index Options, and in current Expiry they have created a buy position of 33934 contracts. However from last 4 days FII and PRO has been continuously creating below average short position, which caution new fresh investment in market.
