Lackluster Movement Expected, As Senate Will Decide On Trump's Health Care Bill

Indian Market Outlook: The Indian Benchmark Index Nifty traded in a narrow range of 50 points from 9049 to 9099 ahead of a Bill to be passed in Senate for accepting Trump's new Healthcare Bill and replealing Obamacare. The Index gave away 4 consective days of loss to close in green at 9086, the Index opened at 9048.

Bank Nifty traded volatile on the last day of its weekly expiry, the Index opened at 20849 and made a low of 20775 and closed at 20895, after making a high of 20935.

Small Cap Index closed near its all time high of 6860 at 6839 after making a high of 6848.

Nifty Future is opening at 9119 as per SGX Nifty at 8:50 am IST, 15 point above its previous close of 9104.

INTERNATIONAL MARKET MORNING UPDATE

International Markets closed flat as healthcare bill got delayed. After a lots of negotiation and drama, White House was not able to reach to any conclusion and the bill got delayed to Friday afternoon as per sources. Currently S&P500 is trading at 2345, yesterday the Index made a high of 2354.

Thus today will be a crucial day for Markets and Trump, as Trump cannot face defection of more than 21 votes from his own party. Total number of voters are 430 and majority required is 216, where Democrats have 193 vote and Republican have 237 votes, hence, if more than 21 member say no to Trump's healthcare bill, then Obamacare will not be replaced. 24 member from Republican party have already confirmed that they are voting against the bill. If bill does not get passed in Trump's favor, all other bills such as infrastructure spending and tax reform, will also come under question.

German Index Dax, closed at 12097. The Index is trading in a narrow range of 400 points between 11830- 12150.

MSCI emerging market is currently trading at 967. Recently the index made high of 979.65. If it goes above 979.65 vou might see buy breakout in Emerging markets.
