**Indian Market Outlook**: The benchmark Index Nifty closed in positive territory after 5 days of continuous negative close. The Index opened at 9108 and made a low of 9103 and closed at 9136 after making a high of 9144.

Bank nifty took support of its 2 week low of 21396 and today made low of exactly 21396 and closed at 21491 after making a high of 21559. HDFC Bank will announce its Q4 result today at arounf 12:30 to 1:00 PM

Small cap made a record high of 7322 and closed at 7319, the Index made low of 7222.

Nifty Future is opening at 9134 as per SGX Nifty at 8:50 am IST, 4 point above its previous close of 9130.50.

The choppy trading on Wall Street came amid geopolitical uncertainty ahead of the first round of voting in the French presidential election on Sunday. Recent polls have suggested the race is too close to call.

German Index Dax continued to trade in a range of 100 points above its breakout level of 12150 and is heading towards its all time high of 12454. Yesterday the Index closed at 12109.

MSCI Emerging market which is a mixed bag of emerging markets Index has given correction of almost 10 points and yesterday closed at 961.78. Recently the Index made a high of 979 and recent low was at 917.
