ECB President Mario Draghi To Announce Monetary Policy Today

ECB President Mario Draghi to announce Euro-zone Monetary Policy at 5:15 PM IST today, the rates are expected to remain unchanged. The primary objective of the ECB's monetary policy is to maintain price stability. The ECB aims at **inflation rates** to be below or close to 2% over the medium term.

Mario Draghi, is set to reveal details of a reduction in monetary stimulus today, this could be the most eventful meeting of the central bank this year.

Analysts expect the ECB to cut its monthly asset purchases from 60 billion euros (\$70.5 billion) to 30 billion euros as of January, with a commitment for nine months, i.e. until end-September 2018.

Market is expected to remain volatile taking cues from Euro-zone meeting.
