World Market:

- A jump in shares of consumer companies Mondelez and Kellogg after their quarterly reports on Tuesday, along with further gains for tech stocks, helped Wall Street end October on a positive note.
- Mondelez jumped 5.4 percent after the Oreo cookie maker reported better-than-expected profit and revenue, while Kellogg surged 6.2 percent following its first sales increase in more than two years.
- Investors are also awaiting an announcement on the next Federal Reserve chair, which could come this week. President Donald Trump is likely to pick Fed Governor Jerome Powell, who is seen as more dovish on interest rates and thus relatively stock market friendly, sources have told Reuters.
- The Dow Jones Industrial Average rose 28.5 points, or 0.12 percent, to 23,377.24, the S&P 500 gained 2.43 points, or 0.09 percent, to 2,575.26 and the Nasdaq Composite added 28.71 points, or 0.43 percent, to 6,727.67.

Asian Market:

- Asian shares looked set to extend their gains into a fourth straight day on Wednesday on the back of solid economic growth, while oil prices were on a bull run on hopes of an extension of output cuts by major oil producers.
- MSCI's broadest index of Asia-Pacific shares outside Japan rose 0.3 percent in early trade while Japan's Nikkei gained 1.0 percent.
- The Nifty50 futures on the Singapore Stock Exchange were trading 37 points higher at 10416 indicating a positive opening for the domestic market.


