Global Update

World Market:

- ❖ The S&P 500 ended flat on Monday after briefly touching a record high, while Wall Street's "fear gauge" dropped to its lowest in over two decades following centrist Emmanuel Macron's victory in the French presidential election.
- ❖ With March-quarter reporting season nearly complete, S&P 500 earnings on average have grown 14.4 percent, and earnings for the June quarter are expected on average to increase 8.6 percent, according to Thomson Reuters I/B/E/S.
- ❖ The Dow Jones Industrial Average edged up 0.03 percent to end at 21,012.28 points and the S&P 500 gained 0.08 points, less than a hundredth of a percent, to end at 2,399.37. It briefly touched a record high of 2,399.94. The Nasdaq Composite added 0.03 percent to 6,102.66.

■ Asian Market:

- Asian equities were mostly muted after soaring in the previous trading session with investors focused on key regional events unfolding in the day, including a presidential election in South Korea and the release of the Australian federal budget.
- ❖ Japan's Nikkei 225 was mostly flat, trading 0.11 percent lower after surging more than 2 percent in the previous session. Hong Kong's Hang Seng Index trader higher by 0.3 percent. Markets on the mainland were softer, with the Shanghai Composite sliding 0.2 percent and the Shenzhen Composite lower by 0.119 percent.
- The Indian equity market is expected to open flat today tracking Asian indices. SGX Nifty is trading at 9344.50, Down by 1.50 points.
