## Global Update

#### ■ World Market:

- The S&P 500 and the Dow were slightly higher on Monday but gains were muted by a fall in technology stocks which nudged the Nasdaq lower as investors turned to more defensive sectors.
- The slow-growing, high-dividend S&P utilities and telecommunications were the best performers among the 11 S&P sectors. Technology stocks, which have been under pressure as investors worry about stretched valuations, hit a session low in late afternoon trading.
- The Dow Jones Industrial Average was up 39.35 points, or 0.18 percent, to 21,434.11, the S&P 500 gained 3.12 points, or 0.13 percent, to 2,441.42 and the Nasdaq Composite dropped 11.12 points, or 0.18 percent, to 6,254.13.

#### ■ Asian Market:

- Asian shares were traded mostly on a positive note, Japanese stocks closed in on two-year highs early on Tuesday thanks to a weaker yen while the euro sagged against its peers after European Central Bank President Mario Draghi talked up benefits of the ECB's easy monetary policy.
- \* MSCI's broadest index of Asia-Pacific shares outside Japan stood flat. Australian stocks lost 0.3 percent while South Korea's KOSPI was unchanged.
- The Indian equity market is expected to open flat today tracking Asian indices. SGX Nifty is trading at 9618.00, Down by 3.50 points.
