Index has formed Spinning top a bullish reversal candlestick pattern which needs confirmation in the form of a higher close on the following day. Earlier Index has violated up sloping trend line which is drawn connecting the previous troughs which is a bearish signal for short term trend. Going ahead index has strong support at 9680, a failure to violate this level can call for a pullback towards 9800 -9870 while support past 9680 comes at 9640.
