Index is facing resistance around 9700 which is the previous peak. Index had earlier given breakout from up sloping channel and is placed around lower trend line, behavior close to this trend line will be closely watched as a failure to sustain above this trend line will make the index resume its previous down move. Going ahead a sustenance above 9700 will open the way for 9740-9780 while support comes at 9620-9540.

Index had earlier given breakout from Rising wedge a bearish reversal price pattern which suggests the short term trend to turn bearish. Going index has immediate support at 23340, till it maintains above this level it is expected to continue its up move towards 23580-23700 while support past 23340 comes at 23270-23100.
