

Price had earlier given breakout from down sloping channel which is a bullish signal for short term trend. Going ahead a sustenance above 9670 will continue the up move towards 9710-9770 while support comes at 9640-9600.

- ⇒ Among Index Option space, Highest Open Interest concentration was seen in 9500 & 9600 Strike price among the PE options. Where as among CE Options Highest Open Interest Concentration was seen in 9700 & 9800 Strike price.
- ⇒ Highest Open Interest Build Up among the PE options was seen in 9450 & 9750 Strike price. Among CE options highest build up was seen in 9800 & 9650 Strike price.


