- Muthoot Finance: Baring Private Equity Partners India has scored its third
 exit over the course of the last three weeks, after the private equity firm
 completely exited its seven-year investment in listed non-banking
 financial company Muthoot Finance Ltd.
- Mahindra & Mahindra: The maker of Scorpio and Bolero SUV, which has
 so far invested close to Rs 500 crore in the business, will be investing
 almost eight times the money Rs 3,500 crore to Rs 4,000 crore in
 the EV business in the next three to five years.
- Patel Engineering: The board of Patel Engineering has approved issue of
 optionally convertible debentures up to Rs 1,240 crore on preferential
 basis/private placement to the lenders of the company by conversion of
 debt under Scheme of S4A. Besides, raising up to Rs 300 crore by way of
 Rights Issue of equity shares with or without warrants.
- Aviation stocks: The IATA data showed that India's domestic RPK -which
 measures actual passenger traffic -rose by 16 per cent in August
 compared to the corresponding month of the previous year. India's
 domestic passenger traffic growth was followed by that of China at 10 per
 cent and Japan at 9 per cent.
- Phoenix Mills: Phoenix Mills announced that the company's wholly owned subsidiary, Market City Resources (MCRPL) has acquired 50 per cent stake in Columbus Investment Advisory (CIAPL) for a consideration of Rs 55.50 lakh.
- Music Broadcast: Radio City, a part of Music Broadcast, announced the launch of its new age web platform radiocity.in Hindi, becoming the only radio network in India to offer an exclusive Hindi website. Radio City was the first radio network In India to take the digital route with the launch of radiocity.in.

Comments- The benchmark indices ended lower on Thursday after four straight sessions of gains, as investors booked profits in oil refiners amid a lack of fresh triggers after the Reserve Bank of India (RBI) kept interest rates unchanged in a move that was widely expected.
