## Domestic-Corporate-

- AU Small Finance Bank: AU Small Finance Bank on Thursday received approval from Reserved Bank of India (RBI) to operate as Scheduled Commercial Bank. AU Small Finance Bank's name has now been included in the Second Schedule of Reserve Bank of India Act, 1934.
- Vedanta: Higher production and strong commodity prices helped Vedanta post a 43 per cent jump in consolidated net profit at Rs 2,036 crore for the July- September quarter. It had posted a consolidated net profit (after taxes, non-controlling interests and share in profit of jointly controlled entities and associates but before exceptional items) of Rs 1,424 crore in the same quarter last year.
- Lakshmi Vilas Bank: Three months after an aborted attempt to merge with HDFC Life, Analjit Singh-controlled Max Life Insurance has entered into formal negotiations with South India-based Lakshmi Vilas Bank to increase its stake in the mid-sized lender to up to 10%.
- ONGC: ONGC plans to nearly double natural gas production in four years as it invests billions of dollars to produce from newer discoveries.

Comments: The Benchmark indices settled flat on Thursday after hitting new highs in Wednesday's trade as some company results including from Tech Mahindra, and JSW Energy disappointed investors, but gains in pharmaceutical shares lent some support.
