- **Hero MotoCorp:** The country's largest two-wheeler maker Hero MotoCorp on Tuesday declared an interim dividend of Rs 55 per equity share for the current financial year.
- **Tata Steel:** Tata Steel UK on Tuesday said it will close the British Steel Pension Scheme to future accrual from March 31 and employees will get a new contributory scheme for their retirement savings thereafter.
- **Wockhardt:** Drug firm Wockhardt said the Health Products Regulatory Authority of Ireland has given nod to the renewal of certificate for its Aurangabad facility.
- **Cadila Healthcare:** The company said that it has finalised a pact with Supernus Pharmaceuticals to settle patent litigation regarding Trokendi XR extended-release capsules, used for treatment of seizures.
- **Jaiprakash Power Ventures:** Brookfield Asset Management, the world's second biggest alternative assets manager, is in talks with lenders of debt-laden Jaiprakash Power Ventures to acquire the firm's three power plants, two people with direct knowledge of the development said.
- **DB Corp:** Media firm DB Corp said it is consolidating promoter and promoter group holding in the company through inter-se transfers between various members. "The persons from whom the shares of DB Corp are intended to be acquired forms part of the Promoter/Promoter Group of DB Corp," .
- **MTNL:** After a hiatus of few years, the proposal to merge BSNL and MTNL is back on the discussion table with top officials at the telecom department once again 'brainstorming' on various options before the two loss-making, state-owned entities.
- **Dilip Buildcon:** The company on Tuesday informed bourses that it has acquired 100 per cent equity shares of Bhavya Infra & Systems Private Ltd.

**Comments:** *The benchmark indices on Tuesday settled the day lower after hitting their two-year highs as recent outperformers such as banks were hit by profit-taking with analysts warning markets could head for a phase of consolidation this week.*
