

- Bharti Airtel: Qatar based Three Pillars PTE will offload its entire 5 per cent holding in Bharti Airtel through a block deal on Wednesday. As per a term sheet, Three Pillars will sell 19.99 crore shares of Bharti Airtel in a price range between Rs 473 and Rs 490 per share.
- Larsen & Toubro: Schneider Electric SE, the French industrial multinational along, with its consortium partner Temasek, has entered final rounds of negotiations with Larsen & Toubro to acquire its electric and automation division for Rs 15,000-Rs 17,000 crore as India's largest engineering group looks to prune its portfolio and exit non-core areas, said multiple people aware of the developments.
- ICICI Bank: ICICI Bank is on course to monetise its third subsidiary in about two years as it prepares to list ICICI Securities, the investment banking and broking unit, on the stock exchanges.
- ONGC: Oil & Natural Gas Corp has sought higher gas prices from the government for a block it plans to develop in the KG Basin, warning that it will otherwise have to mothball the \$600 million-project.
- Telecom stocks: The Telecom Regulatory Authority of India (Trai) is considering removal of the 50 per cent limit on spectrum holdings within a particular band, said people familiar with the matter. The move should help Vodafone and Idea retain all their airwaves once the merger of the two is complete.
- Reliance Communications: The telecom operator is renegotiating its deal
  with Canadian investment fund Brookfield along with other po ential
  buyers for a stake in its tower unit, the telecom company said on
  Tuesday.

Comments: The benchmark indices remained under pressure at closing with Sensex down over 350 points and Nifty ending around 10,350 levels on profit-booking in banks, oil & gas, banking & financials, metals and auto stocks.
