



- Mahindra & Mahindra: Mahindra & Mahindra is in talks with the Karnataka government for further investments in the state as it looks at expanding capacity in its electric vehicles division Mahindra Electric. Karnataka's large and medium industries minister RV Deshpande said he had a meeting with M&M chairman Anand Mahindra on Friday to discuss proposal.
- SBI: Led by State Bank of India, lenders will invoke pledged shares to take control of Essar Power Gujarat, an arm of Ruias-promoted Essar Group. The decision to acquire 51% equity interest has been taken weeks before a slice of the . 4,500-crore outstanding loan ` gets the tag of nonperforming asset, or NPA, in banks' books.
- Titan, Gitanjali Gems: The government's decision to exempt jewellers from the reporting requirement under the Prevention of Money Laundering Act (PMLA) will benefit large players such as Titan, PCJ, TBZ and Gitanjali Gems.
- Coromandel International: The company announced that India Ratings & Research has assigned a rating of IND A1+ to the Commercial Paper programme (Rs 1,400 crore) of the Company.
- Infosys: Infosys shareholders overwhelmingly backed the return of Nandan Nilekani in postal ballot. The shareholders voted in favour of the appointment of Nandan Nilekani as non-executive chairman of the company, the results of the postal ballot showed.
- RCom, TechM: The National Company Law Tribunal (NCLT) will, on November 2, consider admitting an insolvency case filed by Tech Mahindra (TechM) against Reliance Communications (RCom). This is the second such petition against the operator, the first being filed by Ericsson.

Comments- Benchmark indices end flat but continued a steady recovery from recent losses, with consumer sector leading the way, but gains were capped as corporate results kick off later this week
