


- SpiceJet: SpiceJet chief Ajay Singh has settled proceedings against him by regulator Sebi into alleged disclosure lapses in his purchase of shares in the airline.
- Tata Motors: Tata Motors Group on Monday said its global wholesales, including Jaguar Land Rover, rose by nine per cent in March 2017. The company said the global wholesales (including Jaguar Land Rover) for the month under consideration stood at 129,951 units -- up nine per cent -- over March 2016.
- IPCA Labs: Global financial services firm UBS has downgraded IPCA Labs shares to 'Neutral' from 'Buy' and set a target price at Rs 675.
- Unitech: A local court on Monday granted interim bail to real estate company Unitech Managing Directors Sanjay Chandra and Ajay Chandra for three months.
- Suzlon: Wind turbine manufacturer Suzlon Group on Monday said it has bagged an order of 50.4 MW to supply 24 units of its S111 turbines of 120 meters from a power producer for its project in Karnataka.
- Hindustan Composites: The company said its board at a meeting held on April 10, 2017, considered a proposal for 2-for-1 stock split. The board decided to seek shareholders' approval through postal ballot process for the stock split proposal.
- Redington (India): The company on Monday announced that its overseas step down subsidiary, Arena Bilgisayar Sanayi Ve Ticaret AS sold its entire holding of 51 per cent in its subsidiary, Adeo Bilisim Danismanlik Hizmetleri San ve Tic AS, Turkey, for \$1.65 million.
