

- Hathway Cable & Datacom: The board of the company has approved withdrawal of the scheme of demerger of the Broadband business of the company into Hathway Broadband. It also rescinded the earlier decision taken at its meeting held on May 26, 2016 to merge the three wholly owned subsidiaries (WOS) of the company into the company. Hathway Cable also got in-principle approval for spin off the CATV business of the company into the company's WOS Hathway Datacom Central Private Limited.
- Cyient: The company reported 3.17 per cent QoQ fall in its consolidated net profit at Rs 94.16 crore for the guarter ended December 31, 2016 against Rs 97.25 crore in the sequential guarter ended September 30, 2016. Bottom line of the company grew 13.80 per cent on a year-on year-basis.
- Bharti Airtel: Finance Minister Arun Jaitley on Thursday inaugurated Airtel Payments Bank of Bharti Enterprises, which is being rolled out across the country with an investment of Rs 3,000 crore.
- Tata group companies: TCS chief N Chandrasekaran on Thursday appointed as the Chairman of Tata Sons. "The Board of Directors of Tata Sons, at its meeting on Thursday, appointed N Chandrasekaran as Executive Chairman. This is as per the unanimous recommendation of the Selection Committee," the company said in a statement. Chandrasekaran was the CEO and MD of Tata Consultancy Services (TCS).
- Tata Consultancy Services (TCS): The IT major on Thursday reported a 2.9 per cent QoQ rise in net profit to Rs 6,778 crore for the December quarter, which was higher than Rs 6,432 crore profit anticipated by analysts at an ET Now poll.
