Domestic-

DII: Consistent investments by mutual funds and insurance companies in shares over the past few years have increased the might of domestic investors. The total value of holdings of domestic institutional investors (DIIs) as a percentage of the value of foreign institutional investors (FIIs) holdings has reached its highest level in four years.

Corporate-

- Concor:** The share price of India's largest container logistics company, Container Corporation of India (Concor) fell 2.1 per cent on weak December quarter results. Demand is a constraining factor, muted export import (Exim) performance led to the fall in revenue. Exim segment, which accounts for about 80 per cent of Concor's revenue, registered a 6.5 per cent fall year-on-year to Rs 1,058 crore thanks to pressure on pricing, while domestic segment was flat at Rs 272 crore.
- Adani Ports & SEZ :** Adani to buy back Buy back 11,700 non-convertible debentures out of the total outstanding 56,160 non-convertible debentures of face value ₹10 lakh each listed on the wholesale debt market segment of the BSE. The board of directors of the company on Tuesday approved the buyback of the said NCDs aggregating to ₹1,170 crore from existing debenture holders in one or more tranche through negotiated deals as may be agreed upon.

Comments:

Benchmark indices settled the day flat as investors stayed cautious ahead of Janet Yellen's semi-annual testimony, which could hint on further rate hikes.
