### Corporate-

- **REI Agro:** The CBI on Thursday arrested the chairman of REI Agro along with a promoter of the company in connection with an alleged bank loan fraud of Rs 3,871 crore.
- Indian Bank: Public sector Indian Bank has reduced the base lending rate by 0.20 per cent to 9.45 per cent. The new base rate will come to effect from next week.
- Jubilant Life Sciences: The company on Friday announced that Jubilant Pharma, a material wholly owned subsidiary of the company, through one of its wholly owned subsidiaries, has signed an Asset Purchase Agreement with Triad Isotopes Inc. and its parent, Isotope Holdings, Inc. ("Triad") to acquire substantially all of the assets which comprise the radiopharmacy business of Triad. The closing of the transaction is subject to customary closing conditions, including contract, regulatory and other approvals. The acquisition will be funded through JPL's internal accruals and is likely to be earnings accretive in the first full year of operations.
- Wipro: Wipro announced that it has joined Enterprise Ethereum Alliance (EEA) as a founding member. EEA is a collaboration of enterprises to promote, develop and implement enterprise grade Ethereum based blockchain applications across industries for specific business use cases.
- Parag Milk Foods: Dairy products maker Parag Milk Foods expanded its product range with the launch of "Slurp", a mango fruit milk juice, as part of plans to become one of the largest FMCG dairy organisations, a top official said.
- Bharti Airtel: Social networking major Facebook on Thursday joined hands with Bharti Airtel to deploy 20,000 Wi-Fi hotspots across the country to offer affordable internet services through the former's Express WiFi service. These hotspots will begin to be deployed over the next few months.

# Comments

The benchmark indices settled higher on Thursday as banking stocks climbed on a government's move to tackle surging bad loans, with ICICI Bank up over 9% after it said additions to non-performing loans would be lower this year.
