From last 3 trading sessions, Nifty is taking resistance near 10930. Last day, the Index made a high of 10928 and closed at 10905 after making a low of 10845. The Cash market is underperforming the Nifty index. Small Cap has taken resistance of its Week 2 high of 6496 and is currently trading at 6418. If Nifty and Small Cap trades above their resistance levels and sustain, then fresh buying can be seen in the market.

Realty, Energy Oil and Gas and IT were the positive sectors last day. The Investors should track the companies posting good December quarter numbers.
