

Nifty Is Expected ToTrade In A Range Of 10470 To 10600 Friday, April 20, 2018

Indian benchmark Index is struggling to trade above 10600, the Index from last three trading sessions is trading in a narrow range of 10600 to 10500. Nifty yesterday closed at 10565.

Nifty is expected to trade in the range of 10480 to 10530 as most of put writing position has been build up in 10500 strike price of Nifty. Till date, 54.50 lakh shares put writing is build up in 10500 strike whereas on the other side, 10600 Put option does not have enough positions and only 15.85 shares been build up. Thus, this suggests that Nifty may not go above 10600 till more position builds in this strike and is expected not to go below 10470 until positions are squared off in 10500 strike. Nifty April contract is set to expire on 26th April 2018.
