ARVIND **Buy in the range of 94.65 & Upto 93.70 for the Target of 102.00 with the SL of 91.00**

On an hourly chart, the stock is forming "Saucer Bottom" formation which suggests bulls may continue to pull the counter. On a daily chart, the stock has given a breakout of its falling trend line which suggests a robust northward movement in the counter. So for trading perspective, one could Buy in the range of 94.65 & Upto 93.70 for the Target of 102.00 with the SL of 91.00.

GATI **Buy in the range of 84.60 & Upto 84.00 for the Target of 91.00 with the SL of 81.00**

On an hourly chart, the stock is forming Cup and Handle pattern which suggests a bull run in the counter. Moreover, a sudden spurt in the volume has been witnessed during trading session which indicates an accentuate buying in the counter. On a daily chart, the stock is sustaining above its 100 Days Exponential Moving Average which shows upside rally in the counter. So for trading perspective, one could Buy in the range of 84.60 & Upto 84.00 for the Target of 91.00 with the SL of 81.00.

- ❖ IDBI Bank: RBI categorized IDBI Bank as a private sector bank for regulatory purposes with effect from January 21, 2019 consequent upon Life Insurance Corporation of India acquiring 51 percent of the total paid up equity share capital of the bank.
- ❖ Tide Water Oil (India): Board declared 2nd Interim Dividend of 1700 percent (Rs 85) per ordinary share for the year 2018-19.
- ❖ Tech Mahindra: Board approved the proposal to acquire 100 percent shareholding in K-Vision Co through its wholly owned subsidiary Mahindra Engineering Services (Europe). Enterprise value of the deal is \$1.5 million.
- ❖ Emami: SAT passed an order accepting the appeal and quashing the order of the SEBI Adjudicating Officer imposing penalty of Rs 8 lakh on R S Agarwal, Chairman of company.

Global Update

Global Market:

- ❖ The S&P 500 slipped on Thursday, snapping a three-day streak of gains, as uncertainty over when a trade deal between the United States and China would be reached left investors on edge.
- ❖ The Dow Jones Industrial Average rose 7.05 points, or 0.03 percent, to 25,709.94, the S&P 500 lost 2.44 points, or 0.09 percent, to 2,808.48, and the Nasdaq Composite dropped 12.50 points, or 0.16 percent, to 7,630.91.

Asian Market:

- ❖ Asian stocks made modest gains on Friday, tracking improved global sentiment after UK lawmakers voted to delay Brexit and as a weaker yen supported Japanese shares, but a fresh flare up in US-China trade concerns is expected to cap gains.
- ❖ MSCI broadest index of Asia-Pacific shares outside Japan inched up 0.06 percent. Japan's Nikkei climbed 0.9 percent and South Korea's KOSPI rose 0.45 percent.
- ❖ Trends on SGX Nifty indicate a negative opening for the broader index in India, a fall of 19 points or 0.17 percent. Nifty futures were trading around 10,366-level on the Singaporean Exchange.
