

- Fortis Healthcare: Shareholders of Fortis Healthcare have voted to approve its proposed \$1 billion deal with Malaysian healthcare group IHH Bhd, the company told stock exchanges late on Tuesday
- Jet Airways: Blackstone Group LP is in talks to buy a stake in the loyalty program of Jet Airways India, the troubled Indian carrier that's exploring options to raise cash, Bloomberg reported citing sources.
 - **Reliance Industries:** The company has halted gasoline exports from its Jamnagar site, four people familiar with the matter said on Wednesday, causing the profit margin from producing the fuel to jump to its highest since September.
- **Gati:** According to an ET report, Allcargo Logistics is in initial round of talks to acquire a controlling stake in express logistics company Gati.

Comments- The benchmark indices ended higher on Tuesday, taking cues from their global peers and helped by pharmaceutical, information technology and financial stocks.
