Yesterday Nifty opened higher on a positive note remained choppy and continued to trade sideways for the whole trading session. It eventually closed 0.07% higher in positive. Technically on a daily chart it has formed a candle with lower shadow resembling high fluctuations. We expect it to be in a broader consolidation range of 17800-17300. There is a possibility of further fluctuations or one may expect consolidation movement.





Bank Nifty

Bank Nifty too witnessed an identical trend like nifty in fact outperformed benchmark indices and closed 0.66% higher in positive. Technically on a daily chart it has formed spinning candle with small real body signalling indecision. It has also convincingly breached 20 week SMA levels on downside. Thus there is a possibility of further oscillation or one may expect consolidation movement.
